

Wednesday, September 11

Opening Session 3:00 pm - 3:30 pm / Director Harold W. Clarke



Harold W. Clarke grew up in the Canal Zone in Panama. After graduating from Doane College in Crete, Nebraska, in 1974, Mr. Clarke joined the Nebraska Department of Correctional Services as a counselor. He rose through the department, becoming a unit manager, deputy warden, and then warden at the Nebraska State Penitentiary in 1987. In August 1990, he was appointed Director of the Nebraska Department of Correctional Services, a position he held until 2005, when he left Nebraska to become the Secretary of the Washington State Department of Corrections. In November of 2007, Mr. Clarke left Washington to become the Commissioner of the Massachusetts Department of Corrections. Commissioner Clarke left Massachusetts in November 2010 to accept an appointment as the Director of Corrections in the Commonwealth of Virginia. Among other initiatives under Director Clarke's

leadership, the VADOC has had a focus on improving re-entry of offenders in the commonwealth.

In August 2010, he completed a two-year term as President of the American Correctional Association. Mr. Clarke has also served as President of the Association of State Correctional Administrators and served on the Board of Trustees of Doane College.

Keynote Speaker 3:30 pm - 4:30 pm /Brian Hamilton

Brian is the founder of Inmates to Entrepreneurs, a national program that helps people with criminal records start their own small businesses. Inmates to Entrepreneurs is supported by the Brian Hamilton Foundation, which provides access to entrepreneurship to people who wouldn't otherwise have it. Brian co-founded Sageworks, the country's first fintech and largest provider of software to U.S. banks. He sold the company to a leading private equity firm in 2018.

Hamilton holds multiple patents for his work in automating financial analysis. He is a regular guest on CNBC and Fox and is regularly quoted in and writes for all major national media publications. He is also a contributor to Inc. and Entrepreneur magazines.



The first in his family to attend college, Brian holds an undergraduate degree from Sacred Heart University, where he served on the Board of Trustees, and an MBA from Duke University's graduate school of business.

You will learn about the planning phase, steps taken, data collected, the assessment and incorporation of the findings. This is an interactive session that will feature video clips (from key personnel with the US Army National Guard Central Purchasing Department) and actual customized ordering lists currently being used by the US Army National Guard. You will hear about ongoing and current results of this case study and what the implications are to design personalized customer service strategies for other customer groups.
